## Conditions of Agreement

- The Contract for participation shall not become a binding contract between the Exhibitor and the San Francisco Vegetarian Society (hereafter referred to as SFVS) until the contract has been signed by SFVS.
2. Exhibitors shall be responsible for the setup and tear down of their own exhibit. All garbage shall be placed in appropriate trash containers and cardboard boxes must be broken apart for recycling. A \$50 cleaning fee may be assessed to booths not left clean as determined by SFVS and may result in Exhibitor's non-participation in future World Vegetarian Day (WVD) celebration.
  3. No Exhibitor shall exhibit any merchandise or service other than that specified in the contract. The Exhibitor may not promote in their product display or literature any items that do not meet the SFVS food and / or non-food guidelines. Exhibit space shall not be sublet or shared without the permission of SFVS.
  4. The Exhibitor's property shall be placed on display and exhibited at the Exhibitor's own risk and neither SFVS nor the Recreation & Parks Dept of the City and County of San Francisco shall be responsible for the death or injury to any person or for damage, including consequential damages, or loss of property of the Exhibitor, its officers, agents, employees, or invitees resulting from any cause whatsoever and the Exhibitor hereby indemnifies and holds SFVS and / or City and County of San Francisco harmless for any suit, action or claim arising out of any action or failure to act by the Exhibitor.
  5. If the Exhibitor fails to comply in any respect with the terms, conditions, rules or regulations of this contract, all rights of the Exhibitor hereunder shall cease and terminate.
  6. Should any contingency interrupt or prevent the holding of the World Vegetarian Day Celebration, including but not limited to war, terrorism, acts of God, strikes, lockouts or other labor or individual disturbances, riots, failure to secure materials or labor, fire, lighting, tempest, flood, explosion or any other cause, then SFVS shall in no way whatsoever be liable to the Exhibitor.
  7. The Exhibitor will exhibit in a proper manner, and will keep the exhibit space open and staffed at all time during the World Vegetarian Day Celebration hours. SFVS reserves the right to restrict exhibits to a maximum noise level and to suitable methods of operation and display. SFVS shall have the final decision as to what constitutes a proper exhibit and such decision shall be final and binding. If for any reason any exhibit or its contents are deemed objectionable by SFVS, the exhibit will be removed. This provision includes persons, things, conduct, printed matter or any item or attire that SFVS may consider objectionable to the World Vegetarian Day Celebration Day's intent. SFVS further reserves the right to relocate exhibits or exhibitors when in its opinion such relocations are necessary to maintain the character and or good order of the World Vegetarian Day Celebration.
  8. The Exhibitor agrees that no display may be dismantled or goods removed during the entire period of the agreed upon time slot. The Exhibitor agrees also to remove its exhibit, equipment and other exhibit items from the grounds of the World Vegetarian Day Celebration at the end of the agreed upon time slot. In the event of failure to do so, the Exhibitor agrees to pay for such additional costs as may be incurred.
  9. The Exhibitor shall not: (a) commit any nuisance; (b) cause any unusual or objectionable smoke or odor to emanate from its space; (c) do anything which would interfere with the effectiveness of any utility, ventilating or air-conditioning systems on the facilities of the World Vegetarian Day Celebration, nor interfere with free access or passage to the facilities of the World Vegetarian Day Celebration; (d) interfere with the effectiveness of or accessibility to the electrical, plumbing, gas or compressed air systems; (e) overload any floor, ceiling or wall; (f) do or permit to be done any act which might invalidate any insurance policy carried by SFVS or the City and County of San Francisco.
  10. If the exhibit space is not occupied by the opening of the World Vegetarian Day Celebration, this will be considered as a no-show and the space will be deemed forfeited. This forfeited space may be resold, reassigned or used by the SFVS management without obligations on the part of SFVS for any refund whatsoever.
  11. The Exhibitor will confine its activities to the exhibit space allotted and will not solicit beyond the boundaries hereto.
  12. The SFVS reserves the right to decline any application at its discretion.
